The Materials Fee is to be paid directly to the school office no later than August 15, 2007. Families will be given a choice of payment plans and methods of payment and will make payments as directed to the tuition management company chosen by St. Joseph School. It is assumed once enrolled that families will pay the entire per month amount due: no allowance is made for absences or vacations. Any deviation from this must be discussed with the Principal.

If it is determined anytime during the 2007-2008 school year that having chosen "parishioner" status, the obligation as described above is not met, St. Joseph School reserves the right to change my/our status and tuition rate to that of "non-parishioner". If it is determined anytime during the 2007-2008 school year, that my/our status has changed to "parishioner" then the tuition charged from the point of determination will also be changed.
